7a) All Deposits are non-refundable. Should Employer wish to cancel the Engagement Contract, they must inform John Zamot at least 48 hours before the starting time of the Engagement. Any cancellation made with less than 48 hours notice shall require the Employer be responsible to pay the full balance due on the Engagement Contract.

7b) The above form and method payment are understood to be of essence of the agreement. The ARTIST shall not perform if ARTIST has not yet received any and all outstanding compensation, balance or moneys prior to start of performance. In the event that payments are not made as herein provided, ARTIST shall at its option; have the right to refuse to perform and PURCHASER shall remain liable to ARTIST for the agreed price herein set forth.

**ADDITIONAL TERMS AND CONDITIONS**

JZ PRODUCTIONS LTD. ACTS SOLELY AS AN AGENT FOR Artist(s) herein and it is understood by purchaser that JZ PRODUCTIONS LTD. may in no way be held responsible for non-performance, lateness or any other action by Artist(s) which interfere with performance agreement.

Any musician hired to perform on this agreement is free to cease service hereunder by reason of any strike, ban, unfair list, order of requirement of Local 802 of the American Federation of Musicians. The agreement of the musicians to perform is further subject to proven inability due to sickness, accidents, or accidents, or accidents by means of transportation, riots, strikes, epidemics, acts of God, or any other legitimate conditions beyond the controls of the musicians.

In the event the employer fails, neglects or refuses to pay the wage or other payments agreed upon herein and suit is commenced to recover the aforesaid or any part thereof, the employer shall be responsible for the attorney's fees, court costs, and expenses incurred in recovery of the sums due.

Purchaser shall pay and hold ARTIST harmless of and free of from any and all taxes, fees, dues and the like to the engagement hereunder and the sums payable to the ARTIST shall be free of such taxes, fees, dues and the like.
